**40 YEAR TRANSFERRABLE LIMITED WARRANTY CERTIFICATE FOR
CERTAIN COMMERCIAL, RESIDENTIAL & AGRICULTURAL USES**

Wood Treatment Products, Inc. warrants that for 40 years, the treated lumber used in conjunction with a commercial, residential or agricultural structure will be free from such decay or termite damage as would make this lumber structurally unfit for the purpose for which it was used. Only wood bearing the **EnviroSafe Plus™** Warranty Label is covered by this warranty since only such wood has been treated by an authorized treater and is **EnviroSafe Plus™** lumber.

Wood Treatment Products, Inc.'s only obligation under this warranty shall be to replace such quantity of new **EnviroSafe Plus™** product in exchange for wood damaged by termites or fungal decay. This warranty does not cover any removal, installation, reinstallation or freight costs. This warranty does not cover warping, splitting, twisting, checking or other changes in the shape of the lumber. This warranty does not cover damage to **EnviroSafe Plus™** lumber used in any application that is not above ground including foundation systems or in piling, pole or heavy timber type residential construction, used in swimming pool sidewalls or in water immersion applications, used as fence posts, vineyard stakes or tree supports in agricultural applications or damage resulting from any cause other than termites or decay.

This warranty does not cover incidental or consequential damages. Wood Treatment Products, Inc. shall not be liable or responsible for any loss, damage or liability, direct, indirect, incidental, special or consequential, arising out of the sale, use or misuse of or the inability to use, its products.

This warranty is extended only to the owner/occupant of the real estate upon which this product is used or to the owner of any personal property into which this product is incorporated. No warranty, express or implied, including the implied warranties of merchantability and fitness for particular purpose shall extend beyond the period of the lifetime warranty herein. Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental damages, so the above limitations or exclusions may not apply to you.

The owner to whom this warranty is extended or transferred to, agrees to notify Wood Treatment Products, Inc. in writing at the following address: Wood Treatment Products, Inc., P.O. Box 950445, Lake Mary, FL 32795-0445, within ninety days (90) of first learning of a possible defect in the product which may lead to a claim under this warranty. The owner must give Wood Treatment Products, Inc. this notice before Wood Treatment Products, Inc. shall have any obligation under this warranty.

The owner to whom this warranty is extended must file any action against Wood Treatment Products, Inc. to enforce this warranty within one (1) year of first discovering any defect in the product upon which such action is based.

You are advised that in order to make a claim under this warranty, you must present evidence of purchase and the manufacturer's identification tag or ink stamp. Failure to use the product in accordance with instruction or restriction printed on such identification tags or ink stamps, voids this warranty.
